  - If a programme starts on Monday 1 October 2018, after Monday 15 October 2018, once a term has started, students are liable for the full fee for that term, even if you withdraw or take a leave of absence from the programme during the term.
  - If a course has a non-standard start date (i.e., a date other than Monday 1 October 2018), you have 14 days (10 working days) from the standard registration day for a cohort (this can be clarified by the faculty) during which a student can officially withdraw from their programme or take a leave of absence from their studies and a fee will not be levied.
  - In order for the 14 days (10 working days) "cooling off" period to be taken advantage of students are required to contact the faculty office within the cooling off period

- 9. 
